WHAT TYPES OF COOKIES DO WE USE?

Cookies are small packets of information that the browser stores at the request of the website. Cookies enable websites to function properly or more efficiently and provide information to the website owner about the users.

1. COOKIES NECESSARY FOR THE BASIC OPERATION OF THE WEBSITE (ESSENTIAL COOKIES)

- These cookies are essential for the operation of the website. This type of cookie cannot be disabled and does not require user consent.
- Without the necessary cookies, the website will not function at all or will not function as intended, these cookies are essential for the operation of the website or to remember the settings you have made.
- If you, as a user, block these cookies, the website will not function properly.
- Necessary cookies are processed based on our legitimate interest in providing services related to the website, in accordance with Article 6(1)(f) of the GDPR and Section 13/A(3) of Act CVIII of 2001 on Electronic Commerce (Hungarian law).
